We also advise on Education and Environmental Law.**

- **Housing and General Social Welfare Law:** Defended Eviction, defended Mortgage Repossession, Preventing Homelessness, advising on temporary accommodation or rough sleeping, Criminal Injuries Compensation, Education and Environmental Rights and general Social Welfare Law. - **Criminal Injuries Compensation:** telephone for an appointment on 0141 353 3354, or Freephone 0800 316 8450, or call in at a free drop-in on most Wednesdays from 2.00 pm to 4.00 pm.

In addition to standard CICA cases, LSAs lawyers take up historic and complex cases, reviews and appeals, and victims affected by criminal convictions or the “same roof rule”.

- **Mental Health and Incapacity:** A comprehensive legal service for clients, or their carers who have mental health problems or dementia.

This includes Mental Health Detentions, Welfare and Financial Guardianships, Powers of Attorney, Family Disputes, Children's Hearings, Community Care: everything that impacts on people with incapacity.

- **Asylum & Immigration:** Migrant Women and Young People with Immigration/Asylum Issues and Victims of Trafficking.

We offer an holistic service for women, children and young people who need help with asylum and immigration matters. This includes advice and representation for victims of trafficking and migrant women who have experienced gender-based violence.

The Department is dedicated to providing a comprehensive service to our clients and undertakes all relevant tribunals and court work.
